In the 35th District Court, Attorney Sharon Grier secured an acquittal for her client on domestic violence charges. Her masterful cross-examination elicited exculpatory evidence from a hostile complaining witness.

Attorney Ash Al-Awamleh secured an acquittal on an Assault & Battery charge in the 19th District Court. He utilized the skills and expertise of Investigator Lamont Patton and to interview witnesses and survey the crime scene. After filing an interlocutory appeal in the 3rd Circuit, Attorney Gerou was granted a Daubert Hearing. Attorney Gerou's Motion to Suppress, which argued that law enforcement violated MSP guidelines in administering a breath test to his client, was initially denied by the 20th Disctrict Court. However, the 3rd Circuit Court has remanded the case back to the 20th District Court for the hearing. Congratulations!
