Attorney Spotlight

Attorney Miles Gerou secured a dismissal for his client due to a Brady/Youngblood violation, successfully contesting the prosecution's claim that they served discovery. This was compounded by the involved officer's history of a suspicious pretextual stop without preserved video and a separation affidavit citing resignation under a Use of Force investigation. The Judge dismissed the case, ruling that the Police Department's unlawful video retention policy, which destroyed evidence after one year—contrary to MCL 780.316(2)'s mandate for retention until case completion—met the Youngblood bad faith standard.
